## Assembly Proposes \$7 Million Increase for Advantage After School, \$75 Million For Expanded Child Care Subsidies, and \$200 Million for Community Schools Aid

Assembly One-House Budget Bill Shows Leadership in Promoting State Investments to Support New York Families

The Assembly's FY 16-17 one-house budget bill proposes \$87 million to support afterschool and child care for working families across the state. The bill includes an additional \$7 million to support Advantage After School programs and \$75 million to expand child care subsidies, while increasing the Community Schools Aid to \$200 million. AfterSchool Works! NY: the New York State Afterschool Network (ASW:NYSAN) thanks Assembly Speaker Carl Heastie, Children and Families Committee Chair Donna Lupardo, and Education Chair Catherine Nolan for their leadership in providing needed funding for programs that support New York's children and families.

The proposed \$7 million addition to the Advantage After School Program, over last year's budget, is a much needed and long overdue investment. The \$7 million addition would increase the total funding level for Advantage After School to \$24.3 million for FY16-17, which is \$5 million below prerecession levels. This investment is a welcomed addition and a considerable step towards addressing the 1.1 million children still in need of afterschool programs statewide, according to the *America After 3pm* 2014 survey by Afterschool Alliance. This investment would be the largest state increase to afterschool funding since the recession.

Under the Assembly's proposal, \$75 million would also be allocated towards new child care subsidies, serving an additional 10,000 families with a focus on prioritizing homeless families. One-third of child care subsidies are used to support school-age children, including those in afterschool and summer programs, and ASW:NYSAN fully supports this investment.

Finally, ASW:NYSAN would like to thank the Assembly for their addition of \$100 million toward Community Schools Aid, raising the total investment to \$200 million for school districts to support the transformation of struggling and persistently struggling schools to community schools. Ninety percent of community schools incorporate afterschool or expanded learning time, and the strategy prioritizes school-community partnerships to meet the needs of students and families. While this proposed investment is crucial in supporting school districts in their efforts to convert to the community schools strategy, there is no funding included to renew the Community Schools Grant Initiative (CSGI). 30 of the 62 CSGI recipients are currently in their final year of this grant, and without a state investment in CSGI this year to allow for a new round of grants, many schools will face immense pressure next year as the resources provided to their school districts though the

Community Schools Aid will not be enough to sustain the services they have implemented over the previous three years. We call on the Assembly, Senate, and Governor to further demonstrate their commitment to community schools by restoring funding for the Community Schools Grant Initiative in the final State Budget.

**Kelly Sturgis, Executive Director, ASW:NYSAN**, says, "ASW:NYSAN would like to see all of New York State's youth and families have access to high-quality experiences beyond the traditional classroom. We would like to commend Speaker Heastie and the Assembly for their investments in the afterschool and summer programs that will help make this vision closer to a reality. We applaud their dedication to our youth and families, and hope the Senate will also invest in these priorities."
